<b>Description of Use (s)</b>	Seal crash carts, emergency boxes and other areas where evidence of tampering is critical
<b>Preparation for Use</b>	
<b>Diagrams (drawings, pictures):</b>	
<b>Steps for Use of Product</b>	<ol style="list-style-type: none"> <li>1. Pull on wire to remove loose hasp end from seal body</li> <li>2. Pass open end through opening of object to be sealed</li> <li>3. Re-insert hasp end into slot seal body. Firmly push down hasp until it is securely sealed. Pull on seal to insure locking mechanism is engaged.</li> <li>4. Twist seal body to break and remove.</li> </ol>
